

WOODLANDS ARCHITECTURAL CONTROL COMMITTEE (ACC)

RULES AND REGULATIONS

FENCES

1. Fences are permitted only when the fence will be used as a safety barrier to enclose a pool and pool deck.
2. Material shall be metal or aluminum see through vertical slat fence with a flat horizontal top rail cap. NO PLASTIC, WOOD OR CHAIN LINK.
3. Standard Height - 42 inches to 48 inches. Special height of 60 inches if required and approved by the ACC. This height is reserved for properties located near perimeter locations with security issues.
4. Color - black, dark green, white or bronze.
5. Landscaping around fence shall be plant material in accordance with approved plan. Exceptions can be made with ACC approval.

SIGNS

Permanent and/or temporary signs shall not be erected or displayed upon any properties within the Woodlands.

Exceptions:

1. Political signs which shall conform to chapter 18 of the City Code.
2. Security/protective agency signs which shall be located within five (5) feet of the residence.
3. Warning or hazard signs which will be permitted to be located where the hazard may exist.
4. Real estate signs in accordance with the following requirements.
 - a. The signs are placed a minimum of ten (10) feet from the property line.
 - b. Only one (1) sign shall be permitted per property.
 - c. The size of the sign shall be no larger than fifteen (15) inches in height, twenty-four (24) inches in width. The top of the sign when measured from the ground (where the sign is installed) shall not exceed thirty-six (36) inches in height.

d. Open house signs which shall be permitted on weekends only when the subject property is staffed by a real estate agent or the homeowner. The size of the sign shall be no larger than fifteen (15) inches in height, twenty-four (24) inches in width. The top of the sign when from the ground (where the sign is installed) shall not exceed thirty-six (36) inches in height.

e. No open house or directional signs are permitted off the subject property.

TRASH/GARBAGE/REFUSE CONTAINERS

1. Refuse containers shall be maintained in good condition and completely screened from view from the adjacent right-of-way. The only exception to this regulation is when the refuse containers are placed for pickup which shall be no earlier than 7:00 pm the evening before the actual day of pickup and removed no later than 11:00 pm the evening of pickup.

2. BULK TRASH can only be placed out for pickup no earlier than 3:00 pm the evening before the actual day of pickup.

VEHICLE PARKING

1. The parking or storage of automobiles except upon paved or graveled areas is prohibited.

2. The overnight parking or storage of trucks or commercial vehicles is prohibited from 9:00 pm to 6:00 am.

3. The overnight parking of vehicles of any kind upon public right-of-ways is prohibited from 2:00 am to 6:00 am.

4. The parking or storage of boats and boat trailers upon any of the foregoing described lands is prohibited, unless same is stored as to not be visible from any street in the subdivision.

PARKING SURFACES & CARPORTS

Vehicle use areas shall be constructed of concrete, stamped concrete, brick pavers, cast in place stone or of a similar material which provides equivalent durability, aesthetic appearance and maintainability. As asphalt driveways are not permitted by the deed restriction, when a full replacement of an existing asphalt driveway occurs, it shall be replaced with one of the approved surfaces.

Any modification to an existing vehicular use area *shall receive approval from the ACC* and all required permits from with the city prior to construction.

Carports are for the purpose of storing private use vehicles and mechanical driven golf carts only. General storage of personal belongings and other commodities within the confines of the carport visible from the abutting rights-of-way are prohibited. Carports shall be maintained so that there is no accumulation of junk, trash and debris.

EXTERIOR SURFACES AND PAINT COLORS

1. Condition - Exterior surfaces of all buildings and structures including but not limited to roofs, walls, soffits, siding, fascias and vehicular use areas shall be kept free of dirt, grime, mold and mildew. Such surfaces shall also be kept free of faded or chipped paint and shall be maintained in good repair and condition. Such surfaces shall be repainted, recovered or cleaned when ten (10) percent or more of the exposed surface area does not meet the standards set forth herein.
2. Painting - Should any exterior surface of a single-family residence within the community require painting, the property owner shall refer to the "**Woodlands Color Palette**" for the list of approved colors.
 - a. Homes painted white may use any secondary or trim color of their choice.
 - b. All tinted whites (must be considered white per Sherwin-Williams) are acceptable as base, secondary and trim.
 - c. Color selection must be from the same card, no mixing of cards is acceptable unless using white as one of the choices.
 - d. Any brand of paint is acceptable, however, the color needs to be color-matched with these approved Sherwin-Williams shades.
 - e. Garage doors may be wood/faux wood, or painted any untinted or tinted white, a base or secondary color, but not a trim color.
 - f. Front doors may be decorative, or any approved base, secondary or trim color, white, black or red.
3. Roof Surfaces - Roof surfaces are not subject to these regulations unless the roofing material is painted. Roof surfaces comprised of shingles, tile or aggregate with a factory-installed color finish are not subject to these regulations. In the event that a roof surface is to be painted or repainted, only (1) color listed as a building base color or accent color shall be permitted, shall match a color used on the elevations of the structure, and shall not be subject to the percentage limitations within the City Code.
4. Exterior surfaces consisting of natural stone, wood or brick shall not be subject to these regulations unless such surface is painted.
